



Student Exchange Policy, Academic Year 2021 (No. 2)

Referring to the Chulalongkorn University Announcement Guidelines for Traveling to and from Foreign Countries for the Purpose of Studying, Training, Teaching or Researching during the COVID-19 Pandemic, dated May 24, 2021, covering all the student exchange programs, the Division of Global Academic Affairs at the Office of International Affairs and Global Network has set the student exchange policy for the academic year 2021 (No. 2) as follows:

1. Outbound student exchange program

Chulalongkorn University students who have applied for and/or have been accepted on a student exchange program for the whole academic year 2021 (the first and the second semesters) before May 24, 2021, may comply with the Student Exchange Policy, Academic Year 2021 dated January 29, 2021. However, they are encouraged to complete two shots of vaccine against COVID-19 in accordance with the health requirements of Thailand before they leave the country.

From the second semester of the academic year 2021 (January – May 2022) onwards, a Chulalongkorn University student who wishes to spend one semester at a partner university may apply for the student exchange program on the condition that his/her application has been approved by the Dean/Director of his/her Faculty/Institute/School. Together with the request for approval or permission, the student must demonstrate that he/she has received two doses of COVID -19 vaccine and the date of his/her departure from Thailand must be at least 14 days after the second vaccination. He/she is also required to attach a study plan while he/she is at the partner university, his/her COVID -19 infection prevention plan and in case of being infected with the virus, his/her COVID -19 action plan, including medical expenses and care while receiving treatment abroad.

2. Inbound student exchange program

Exchange students from partner universities who have applied for and/or been approved for the student exchange program for the whole academic year 2021 (the first and the second semesters) before May 24, 2021, may comply with the Student Exchange Policy, Academic Year 2021 dated January 29, 2021. However, they are encouraged to receive vaccine



against COVID -19 in accordance with the health requirements of their country before their departure for Thailand.

From the second semester of the academic year 2021 (January – May 2022) onwards, a partner university may nominate a student who wishes to spend one semester at Chulalongkorn University to the student exchange program and the student's application must be approved by the Dean/Director of the host Faculty/Institute/School. Before his /her departure for Thailand, the exchange student must receive COVID -19 vaccine in accordance with the health requirements of his/her country; he/she must observe the regulations, announcements or orders of the Thai authorities upon his/her arrival in Thailand and he/she is required to attach a COVID-19 infection prevention plan and a COVID-19 action plan in case of being infected with the virus, including medical expenses and care while receiving treatment in Thailand.

This student exchange policy may change if Chulalongkorn University cancels its announcement concerning this matter and issues a new one which is more appropriate to the Covid-19 infection situation. Therefore, if a Chulalongkorn University student is accepted to the student exchange program or a foreign student receives acceptance from Chulalongkorn University this does not guarantee that he/she will be able to go abroad or come to Thailand. This will depend on the decision and the consideration of the COVID-19 Emergency Operation Center Committee of Chulalongkorn University.
